Can Shed is a full-service redemption center. Walk-in centers located in Cedar Rapids, Hiawatha, Iowa City, Manchester and Marion. In addition to our walk-in customer service, we also offer commercial pickup service.

OUR SERVICES

Can Shed redeems containers that are eligible for an Iowa Refund. Each container is redeemed at the full five cents if it is brought to one of our redemption locations noted above. We also offer a pickup service for commercial accounts. Pricing for our pick-up service is as follows:

We prefer glass be returned in original boxes. (Beer in beer boxes, wine/liquor in wine/liquor boxes). Other sturdy, stackable boxes may be used, but MUST be in counts listed above.

We do require the use of our can bag/box system for commercial accounts with aluminum or plastic product. The can box is \$7.00+ tax; the bags are \$0.50. Can bags are kept in stock on each truck so they are always available for purchase. Can boxes are available for purchase upon request. The initial purchase of boxes or bags must be paid in cash at one of our walk-in centers.

There is no need to sort by vendor. All brands can go together.

We offer pickups on scheduled or an as needed (call-in) basis. We do require at least \$50.00 worth of product to use the pick-up service. There is a trip charge of \$15.

PAYMENT

Invoices are paid 45 days after the day of pickup or 45 days after the invoice that makes your account hit the \$100 minimum required for a check to print.

Items need to be ready and accessible at the time of pick-up. Here are a few guidelines regarding how items should be organized for pickups. Following these guidelines will ensure efficient service and better customer relations.

- ❖ Cans and plastic must be in Can Shed liners and sorted by size according to the chart on the first page. The bags should be tyed in square knots, no ties, tape, other knot types, etc. Items may not be flattened or smashed unless they are from reverse vending machines. Bags must not contain trash or excessive amounts of liquid per Iowa code. **Bags with excessive liquid will be refused.**

IOWA CODE 567-107.7(455C) BEVERAGE CONTAINERS MUST BE REASONABLY CLEAN. Consumers shall take care to return containers in a reasonably clean and intact condition. In order to be redeemed, an empty beverage container shall be dry and free of foreign materials other than the dried residue of the beverage.

- ❖ Glass bottles must be in boxes, not bags for the safety of our employees. Please refer to the size and quantity guidelines on the front of this page. If boxes of glass are stored outside, they must be kept dry. We will not pick the items up if the boxes are wet and falling apart.
- ❖ All non-deposit plastic and cans must be separate from redeemable items and grouped by product type. Cans in one bag, plastic in another. We will pick these items up; however, there will be no corresponding payment. Please also note these items will be taken as long as we have room on the truck.
- ❖ Items need to be in specific area and easily accessible. Snow and ice must be cleared and doorways or walk ways should not be blocked by other debris. **Also, we will not pick up product that requires the use of stairs. Carting product up or down stairs has been determined to be unsafe by our insurance company/provider. They will not allow us to do it.**

If this is currently the case, your route manager can discuss alternatives with you to continue service. This could be an advance call or a change in your time or day for pick up.
